

NORTHERN VILLAGE OF AIR RONGE

Bylaw No. 2024-13

The Sign Corridor Bylaw

Adopted November 26<sup>th</sup>, 2024

A Bylaw of the Northern Village of Air Ronge in the Province of Saskatchewan, in respect to regulating billboards located within a Sign Corridor administered by the Northern Village of Air Ronge.

The Council of the Northern Village of Air Ronge in the Province of Saskatchewan enacts as follows:

1. All applications to place a sign in the sign corridor shall be in form “A”.
2. Approval to establish a sign in the sign corridor shall be issued in form “B”.
3. Signs situated in the sign corridor shall be subject to the following regulations:
  - a) The applicant is responsible for any alterations to telephone or power lines or other utilities made necessary by the work authorized in the permit.
  - b) Erection of the sign shall be made within six calendar months of the date of the permit.
  - c) Signs must be 8 feet x 12 feet (96 Sq. Ft.) in size.
  - d) The south facing side of the sign must be professionally produced using paint, vinyl or ink applied to an acceptable sign surface such as coroplast, aluminum, aluminum composite or similarly acceptable sign surface. The north facing side shall either be covered with a white or neutral sign surface secured to that side.
  - e) Signs to be placed 236 ft. apart and the top of the sign shall be 12 feet from the existing ground level.
  - f) Sign supports shall be constructed as per the sketch shown on Schedule “C” of this bylaw.
  - g) When the sign is in need of repair Village staff will provide notification to the sign owner, and if no action is taken within two weeks by the individual or corporation to remedy their sign, the Village staff will remove sign from the corridor.
  - h) The signing corridor will begin at the most southerly end of the corridor and proceed north.
  - i) Before any sign is to be erected in the sign corridor a proof of the sign design must be provided to the Village. The proof design must be approved by the Village of Air Ronge CAO and attached to the Village’s copy of the permit (Form B).
  - j) Any alterations to previously approved sign designs must be submitted and approved by the Village CAO prior to sign modification.
4. All owners of signs in the sign corridor shall pay an annual fee of \$200 to the Northern Village of Air Ronge for maintenance of the sign corridor. The fee is to be

paid within 60 days of invoicing by the Northern Village of Air Ronge. Failure to pay the fee will result in the removal of the sign from the corridor.

5. Fees for the sign corridor will not be pro-rated.
6. Payment of the annual fee must be made in full prior to approval of the application.
7. Repeal Bylaw No. 143/96 and Bylaw No. 134/94
8. This Bylaw shall come into force and take effect January 1<sup>st</sup>, 2025

Village of Air Ronge – Sign Corridor Permit

to erect a sign in the Air Ronge sign corridor subject to the following conditions:

Signs situated in the sign corridor shall be subject to the following regulations:

- a) The applicant is responsible for any alterations to telephone or power lines or other utilities made necessary by the work authorized in the permit.
- b) Erection of the sign shall be made within six calendar months of the date of the permit.
- c) Signs must be 8 feet x 12 feet (96 Sq. Ft.) in size.
- d) The south facing side of the sign must be professionally produced using paint, vinyl or ink applied to an acceptable sign surface such as coroplast, aluminum, aluminum composite or similarly acceptable sign surface. The north facing side shall either be covered with a white or neutral sign surface secured to that side.
- e) Signs to be placed 236 ft. apart and the top of the sign shall be 12 feet from the existing ground level.
- f) Sign supports shall be constructed as per the sketch shown on Schedule “C” of this bylaw.
- g) When the sign is in need of repair Village staff will provide notification to the sign owner, and if no action is taken within two weeks by the individual or corporation to remedy their sign, the Village staff will remove sign from the corridor.
- h) The signing corridor will begin at the most southerly end of the corridor and proceed north.
- i) Before any sign is to be erected in the sign corridor a proof of the sign design must be provided to the Village. The proof design must be approved by the Village of Air Ronge CAO and attached to the Village’s copy of the permit (Form B).
- j) Any alterations to previously approved sign designs must be submitted and approved by the Village CAO prior to sign modification.
